Sub: Request for deployment of Addl. Director (Admn.) in Ch. Brahm Prakash Ayurved Charak Sansthan on deputation.

Respected Sir,

Ch. Brahm Prakash Ayurved Charak Sansthan (CBPACS) is an autonomous body under Directorate of Health which is run by providing Grant-in-Aid from Government of Delhi. The Academic Section of the Institute is affiliated with Guru Gobind Singh Indraprastha University.

In CBPACS the institutional as well as hospital activities are carrying out for which approximately seven hundred students are studying in different streams under UG and PG courses. In addition approximately two thousand patients are being attended in OPD and 210 patients are admitted in IPD. The campus of institute is also having hostel and accommodation facility in addition to Herbal Garden in appx. 55 acre.

As per sanction post order one post of Addl. Director (Administration) is available in CBPACS and which is lying vacant since inception of this Sansthan i.e. year 2009. Non presence of Addl. Director (Administration) hampers the work and functioning of the usual routine day-to-day work of Administration. Recruitment Rule of Addl. Director (Admn.) is as under;

Deputation: from Officers of IAS/DANICS cadre/UTs Cadre:

(1) Holding analogous posts on regular basis in the parent cadre/department;

Or

(ii) With 05 years or more service in the grade rendered after appointment thereto on regular basis in the grade pay of Rs. 7600 in PB-3 in the parent cadre/department.

Or

(iii) With 10 years or more service in the grade rendered after appointment thereto on regular basis in the grade pay of Rs. 6600 in PB-3 in the parent cadre/department;

(The period deputation/contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed 3 years).

The maximum age limit for appoint appointment by deputation (including short-term contract) shall be, not exceeding 58 years, as on the closing date of receipt of applications.
