CIRCULAR

Chief Secretariat(Works) -- Filling up of one vacant post of Chief Town Planner in Town and Country Planning Department, Puducherry which is classified as General Central Services - Group 'A' - Gazetted - Non Ministerial cadre - Re-Notification -- Reg.

It is hereby re-notified the vacancy of one post of Chief Town Planner in Town and Country Planning Department, Puducherry, which is classified as General Central Services - Group 'A' Gazetted - Non Ministerial, carrying pay in Level-12 of Pay Matrix 2016 of 7th CPC, in the event of nil response from the eligible Officers with respect to the previous Notification dated 19.05.2023 inviting applications for filling up the post. The method of recruitment is as per the requirement given below:

2. The method of recruitment to the post is by promotion / transfer on deputation (including short term contract) and in case of recruitment by promotion/deputation/transfer, the method of recruitment is as follows:

1.(a) Officers of Central/ State Government/Union Territories/ Research Institutes/ Public Sector Undertakings/ Statutory/Autonomous Organizations/ Universities/ Semi-Government Organizations

- (i) Holding analogous posts on regular basis: or
- (ii) With 5 years regular service in Pay Level-11 of Pay Matrix or equivalent; and
- (b) Possessing the qualifications and experience prescribed for direct recruits under column 8 in Recruitment Rules as mentioned below:

Essential

- (i) Degree in Regional/Town Planning from a recognized University/Institution or equivalent.
- (ii) 10 years experience in Town and Country Planning with at least 5 years experience should be in a Senior Supervisory capacity.
- (iii) Associateship of Institute of Town Planners (India) or equivalent Membership of a Professional Institution.

Note 1: Qualification are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note 2: The qualification(s) regarding experience is/are relaxable at the discretion of the Union Public Service Commission in the case of candidates belonging to the scheduled castes of and scheduled tribes if at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these Communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

Desirable:

- (i) Degree in Architecture/Civil or Municipal Engineering from recognized University or equivalent.
- (ii) Knowledge of Tamil.

(The departmental Senior Town Planner with 5 years regular service in the post will also be considered along with the outsiders and in case, he/she is selected for appointment to the post, the same shall be deemed to have been filled by promotion. (The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed 4 years).

3. Regulation of pay and other terms of deputation:

The pay of the selected officer will be regulated under the provisions contained in the Department of Personnel and Training O.M.No.6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended from time to time.

4. Age Limit : The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

5. Consultation with Union Public Service Commission, New Delhi:
Consultation with Union Public Service Commission is necessary.


6. Reservation for Scheduled Caste / Scheduled Tribes: No provision for reservation exists for the posts to be filled up on deputation basis.

3. It is requested that this circular may be given wide publicity by circulation to all offices / Organizations etc. The applications (in duplicate in the proforma as published in the departmental website <https://tcpd.py.gov.in>) alongwith the complete Annual Performance Appraisal Report (APAR) Dossiers for last five years of the eligible officers who could be spared in the event of their selection, may be forwarded by the respective employer to 'The Under Secretary to Government (Housing), Chief Secretariat, Puducherry 605 001' within 6 weeks i.e., 42 days from the date of publication of this Re-notification in the Employment News. Besides, the following information / documents may also be sent alongwith application:

- (i) A statement showing minor or major penalties imposed, if any in respect of the official.
- (ii) Cadre Clearance Certificate
- (iii) Integrity Certificate
- (iv) Vigilance Clearance
- (v) Job description of the present post held

4. Applications that are not routed through the competent authority and the applications received after the last date or without the APAR Dossiers or otherwise found incomplete will not be considered. While forwarding the applications, it may be verified and certified by the employer concerned that the particulars furnished by the officers are correct and that no disciplinary case is either pending or contemplated against the Officer. The applicants may please be informed that they will not be permitted to withdraw their applications at a later stage.
