

Haj is an annual pilgrimage conducted in the Kingdom of Saudi Arabia(KSA), with pilgrims congregating from all over the world including India. Every year, Ministry of Minority Affairs deputes Administrative Deputationists i.e. (i) Coordinators (Admin.), (ii) Assistant Haj Officers, and (iii) Haj Assistants to Consulate General of India (CGI), Jeddah for rendering assistance to CGI, Jeddah in the management of Haj operations in general and Indian Haj pilgrims in particular.

- 2. In this context, an O.M. no. HAJ-16/10/2023-HAJ-MoMA dated 10.11.2023 was issued by this Ministry (copy enclosed) inviting online applications from Male and Female employees amongst the Muslims officials working in the All India Services, Central Civil Services, Central Armed Police Forces (CAPFs) and State Police forces for temporary deputation to CGI, Jeddah for Haj-2024. The period of deputation will be approximately 3 months tentatively from May, 2024 to July, 2024. The last date for submitting online application on Haj deputation portal was 09th December, 2023 and the last date for receiving of applications (online generated) through proper channel in this Ministry is up to 20th January, 2024.
- 3. In this context, it is informed that applicants (as per the list enclosed from your State / UT) have applied online for the said deputation. This Ministry will be selecting candidates whose applications are received through proper channel. Since the selected officials will be required to be deployed in KSA for rendering assistance to CGI, Jeddah, they should not be deployed for Parliamentary election-2024 or for any other duties, so as to ensure that these candidates are readily available for deputation, during the said period.
