- The Chairman of the Commission shall before taking charge of the office as Chairman divest himself/herself from the interest in all or any the business mentioned in Para-3 as a condition of his/her appointment.

- 6. If person to be appointed as a Chairman of the Commission holds any office under the State Government or in any public sector corporation or Government body he/she shall submit his/her resignation or take voluntary retirement from that service and shall not seek reappointment in the service of the State Government the Central Government, any public sector corporation or Government body at any time after he/she ceases to be Chairman of the Commission.
- 7. So long as the person holds the office of Chairman of the Commission and after he/she ceases to be Chairman of the Commission for any reason whatsoever, he/she shall not acquire, hold or maintain, directly or indirectly any office employment or not acquire arrangement or business mentioned in para-3 and if he/she acquire any such interest involuntary or by way of succession or testamentary disposition he/she will divest himself/herself from such interest within a period of two months of such interest being acquired.
- 8. The salary and allowances and other terms and conditions of the service of the Chairman shall be as per the Uttarakhand Electricity Regulatory Commission (Salary, Allowances and other Conditions of Service of Chairperson and Members) Rules, 2006 and amended Rules, 2009. The tenure of Chairman of the Commission shall be for a period of 5 years or till he/she attains the age of 65 years, whichever is earlier.
