

THDC India Ltd. is a Schedule 'A' Mini Ratna CPSE with the administrative jurisdiction of Ministry of Power, Government of India.

The Registered Office & Corporate office of THDC India Limited are located at Bhagirathi Bhawan, Top Terrace, Bhagirathipuram, Tehri Garhwal – 249001, and Ganga Bhawan, Pragaripuram, Bye-Pass Road, Rishikesh-249201, respectively in Uttarakhand.
