

ORDER NO. 20

In partial modification to this office Order No. 31 dated 11.10.23 wherein 2<sup>nd</sup> financial upgradation granted to Sh. Ashok Kumar (Now Gr.II(DASS)/ASO) (DOB 10.06.67) under MACP Scheme at S. No.03. This order has been reviewed by the designated Screening committee and accordingly, 2<sup>nd</sup> MACP benefit to Sh. Ashok Kumar Gr.II(DASS)/ASO, is granted herewith from existing pay scale of Rs. 5200-20200/- with Grade Pay 2400/- (Revised Level 4 in pay matrix of 7<sup>th</sup> CPC) to the immediate next higher Grade Pay of Rs. 2800/- (Revised Level 5 in pay matrix of 7<sup>th</sup> CPC)- in the hierarchy of the recommended revised pay bands w.e.f. the date mentioned against his name as under:-

- The grant of MACP is further subject to the condition that:-
- 1) The Official concerned may be allowed to exercise his options, if any, under FR 22 within one month of the issuance of the Order granting the financial upgradation under the Modified Assured Career Progression Scheme.
  - 2) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.
  - 3) Officials who are on deputation will get financial upgradation from the date shown against his name only on notional basis, however, he will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his repatriation to Delhi Government.
  - 4) The concerned Head of Department is requested to ensure before issuance of formal order for grant of 2<sup>nd</sup> financial upgradation under MACP Scheme that the Official concerned has not refused regular promotion before becoming entitled to a financial upgradation in accordance with provisions contained in Para 25 of Annexure - I of DoPT, Govt. of India O.M Dated 19.05.2009 and Para-24 of Annexure-I of O.M dated 22.10.2019.
  - 5) The concerned Head of Department is requested to issue formal order for grant of the 2<sup>nd</sup> financial upgradation under MACP Scheme in respect of Sh. Ashok Kumar and also verify the service particulars with regard to date of appointment etc. as mentioned above are correct. Discrepancy, if any be brought to notice of this Department and the orders in respect of such Official may not be implemented till clarification received from this Department. Further, it may be re-ensured that the Official is clear from vigilance angle at all levels and is not under the currency of penalty, at the time of eligibility.


