As you are aware, cadre review of civilian cadres in Government of India falls under the jurisdiction of the respective Cadre Controlling Authorities and is required to be undertaken periodically. However, it has been observed that proposals for Cadre Review for Group B and C categories are received in the Department of Expenditure after long periods of twenty to thirty years or even for the first time. This delay is not in consonance with good HR management practices.

- In this context, you may appreciate that regular cadre reviews have an important role in overall development of any organisation. Besides, it provides a healthy balance between the functional requirements of the organisation and career progression of the members of the respective cadres. Cadre reviews also provide opportunities to realign the cadres in harmony with the recent initiatives taken by the Government of India and help in maintaining high level of morale and efficiency
- It would be appreciated if all the Cadre Controlling Authorities under your Ministry / Department are advised that cadre reviews of each cadre of Group B and C categories are conducted regularly, Ideally after every 5 years. The Cadre Controlling Authorities may be asked to review the position and to initiate cadre reviews where a long period has passed since the previous cadre review or where
- I would request you to accordingly issue suitable instructions to the Cadre Controlling Authorities under your administrative control to undertake a comprehensive review of all cadres and Initiate cadre review wherever necessary
