As per the directions of the Hon'ble Supreme Court and the Scheme for Compassionate Appointment issued by Govt. of India vide DOPT OM No.F14014/6/94-Estt.(D) dated 09.10.1998 and OM dated 26.09.1995, 5% of direct recruitment quota in Group-"C" and Group-"D" posts under direct recruitment quota are to be allocated for compassionate appointments, hence, in view of this, 5% of the total vacancies meant for direct recruitment, may be held back for compassionate appointments.
