- (a) (i) holding analogous post on regular basis in the parent cadre or department; or (ii) with five years service in the grade rendered after appointment thereto on regular basis in the posts in level 11 in pay matrix (Rs. 67,700-2,08,700/-) in the parent cadre or department; and
- (b) possessing the educational qualifications and experience as under:
