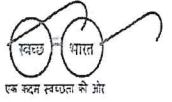

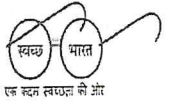

Supervising the work of the deckside staff during operation of the fishing vessel, Vessel maintenance, maintenance of fishing gears, loading, preservation and unloading of catch, upkeep of navigation records, mess activities, arranging day & night watch duty on board the fishing vessel.
