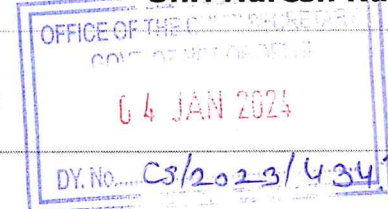

**Subject: Filling up of posts in Sixteenth Finance Commission on deputation basis - calling for nominations/applications.**

The Sixteenth Finance Commission (SFC) has been Constituted by the Government of India on 31.12.2023. The Commission's tenure is upto October 31, 2025 and the posts created (**Annexure-A**) for the Commission would be filled up on deputation basis.

2. The appointments to the Sixteenth Finance commission will be governed by regular norms prescribed by DoP&T from time to time. Specifically, the applicant should be holding an analogous post or be eligible to be appointed to the post applied for under the normal rules of selection prescribed. The officers/officials holding analogous post and appointed on deputation basis with the Commission would be eligible for a deputation allowance at the prescribed rate. Appointment to the next higher level of the regular post held by official would be subject to fulfillment of the eligible criteria for the said post.

3. It is, therefore, requested that this requirement of the Commission is circulated among the concerned officials/personnel in your Ministry/Department including attached, subordinate offices and autonomous bodies. The nominations/applications of willing officers for the various post along with supporting documents may be sent to the Sixteenth Finance commission **only** by email at [secy-fc@gov.in](mailto:secy-fc@gov.in) with a copy to [manish.kr1975@nic.in](mailto:manish.kr1975@nic.in) in the proforma enclosed (**Annexure B**) along-with cadre and vigilance clearance. **No physical copy be sent for this purpose at this stage.** This is an open-ended circular i.e. all completed applications of eligible candidates will be considered on regular basis and this process will continue till all the vacancies are filled up. It is, therefore, requested to send the duly filled/verified applications at the earliest.
