I am directed to say that one post of "Senior Scientist" in the Andaman Lakshadweep Harbour Works, Port Blair, Andaman & Nicobar Islands (functioning as a Sub-ordinate Organisation under the Ministry of Port Shipping & Waterways, New Delhi) is proposed to be filled up by deputation (including short-term contract) basis for a period of two years. The period of deputation can be extended/curtailed as per requirement. The post is a General Central Service "Group A" Gazetted (Non-Ministerial) in the Level-11 of Pay Matrix as per 7th CPC (Pay Band PB-3 ₹15600-39100 + GP ₹6600 as per 6th CPC)

The Head Quarter/place of posting will be at "Port Blair" in Andaman & Nicobar Islands. The total emoluments in Level 11 in the initial pay is approximately ₹113620/- (₹67700/-plus present 50% DA of ₹33850/-plus SCA/TLA ₹5300/- plus ISDA @ 10% ₹6770/-).
