2. Scale of Pay : Level- 07, Rs.44900-142400/- (Pre revised Pay in Pay Band-2, 9300-34800 +

Grade Pay 4600)

3. Number of Posts: One (1)

4. Method of Recruitment: By Deputation (including Short-term contract) Officers under the Central or State Governments/Union Territories/Universities, autonomous or statutory organizations.

- (a) (i) Holding analogous posts on regular basis in the parent cadre or department; or
  - (ii) With 05 years regular service in Level- 06 (Pre-revised Pay Band PB-2, 9300-34800) + Grade Pay 4200 rendered after appointment thereto on a regular basis or equivalent in the parent cadre/department; and
- (b) Possessing the educational qualifications and experience as prescribed in column No. 5

"Note: Period of short-term contract, including period of short-term contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment on deputation (including short-term contract), shall be not exceeding 56 years as on the closing date of the receipt of applications.
