G.S.R. 305(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Directorate of Inspections and Audit(Customs and Central Excise) Administrative Officer/Assistant Chief Accounts Officer, Recruitment Rules, 1986, the Directorate of Preventive Operations (Administrative Officer) Recruitment Rules, 1986, the Directorate General of Revenue Intelligence and Directorate of Anti-Evasion, Customs and Central Excise Recruitment Rules, 1990, the Directorate of Statistics and Intelligence, Customs and Central Excise, Administrative Officer/Assistant Chief Accounts Officer, Recruitment Rules, 1988, the Customs and Central Revenues Control Laboratory) Recruitment Rules, 1969 and the Ministry of Finance, Administrative Officer (Central Board of Excise and Customs, Administrative Officer(Group 'B' Post) Recruitment Rules, 2013, except as respects things done or omitted to be done before such suppressions, the President hereby makes the following rules regulating the method of recruitment to the post of Administrative Officer in the field formations and Directorates under the control of Central Board of Indirect Taxes and Customs, Ministry of Finance, Department of Revenue, namely:-

1. Short title and commencement.-(1) These rules may be called the Ministry of Finance, Department of Revenue, Central Board of Indirect Taxes and Customs, Administrative Officer, Group 'B' Post Recruitment Rules, 2020.

- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Special provision.-(1) Each Zonal Cadre Controlling Authority shall have its own separate cadre unless other-wise directed by the Central Board of Indirect Taxes and Customs.
- (2) Directorate General of Performance Management, Customs and Central Excise, Delhi shall be the Cadre Controlling Authority for Group 'B' post of Administrative Officer for the following Directorates under the Central Board of Indirect Taxes and Customs:-
 - (i) Directorate General of Performance Management;
 - (ii) Directorate General of Revenue Intelligence;
 - (iii) Directorate General of Goods and Service Tax Intelligence;
 - (iv) Directorate of Logistics;
 - (v) Directorate General of Tax Payer Services;
 - (vi) Directorate General of Systems and Data Management;
 - (vii) Central Revenue Control Laboratory;
 - (viii) Directorate General of Vigilance;
 - (ix) Directorate General of Anti-Profitcering;
 - (x) Directorate General of Export Promotion;
 - (xi) Directorate General of Audit;
 - (xii) Directorate of Legal Affairs;
 - (xiii) Directorate General Human Resource Development;
 - (xiv) Chief Commissioner(Authorised Representative), Customs, Central Excise and Service Tax Appellate Tribunal(CESTAT);
 - (xv) Directorate General of Analytics and Risk Management;
 - (xvi) Directorate General of Valuation;
 - (xvii) Directorate of International Customs; and
 - (xviii) Directorate General of Goods and Service Tax.
- (3) The post of Deputy Office Superintendent shall be placed en-bloc senior to the post of Senior Tax Assistant and the service rendered in the grade of Deputy Office Superintendent and Senior Tax Assistant shall be counted towards the eligibility for promotion to the next higher grade.
- (4) Inter-se-seniority of all merged Directorate's posts in the grade of Group 'B' and Group 'C' shall be integrated as per the instructions or guidelines issued by the Government of India from time to time in this regard.
- 3. Number of post, classification, level in pay matrix.—The number of the said post, its classification and the level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 4. Method of recruitment, age-limit, qualifications, etc.-The method of recruitment, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 5. Disqualification.-No person,-
 - (a) who, has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving.—Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backword Classes, economically weaker section, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
