I am directed to refer you on the subject noted above and to apprise that applications of willing officers are invited to fill up the following posts in Excise and Taxation Department, Chandigarh Administration in the pay level mentioned against the post from officers of the Central Government/ State Government /Union Territories holding analogous posts on regular basis in the parent Cadre.

2. The above post will be filled up by way of deputation basis as per eligibility criteria as prescribed in the Excise and Taxation Department, Union Territory, Chandigarh (Group 'B') Recruitment Rules 2018, which is as under:-

"Deputation:

Officers under Central Government/ State Governments/Union Territory Administrations:

- (A)(i) Holding analogous post on regular basis in the parent cadre/Department;
or
(ii) With two years' service in the grade rendered after appointment thereto on a regular basis in the posts in PB-2 Rs.9,300-34,800 with Grade pay of Rs.4,600 or equivalent in the parent cadre or department; or
(iii) With six years' service in the grade rendered after appointment thereto on a regular basis in posts in PB-2 Rs.9,300-34,800 with Grade pay of Rs.4,200 or equivalent in the parent cadre or department; and
(B) Possessing the following educational qualifications and experience;
(i) Bachelor's Degree from a recognized University/Institute; and
(ii) Three years' experience in Excise and Taxation matters in a Government Department."

Note 1: The departmental Officers in the feeder category who are in direct line of promotion will not be eligible for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. (Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same

or some other organization/ department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications).

3. While forwarding the applications of the eligible and willing officers, the particulars furnished by the applicants should be duly verified/ countersigned by an officer, not below the rank of Joint Commissioner/ Director. The last date of receipt of applications is **30 days from the date of issuance of this letter.**

5. The willing and eligible officers are requested to send their application through proper channel, addressed to "Secretary Excise and Taxation, Chandigarh Administration, Chandigarh Secretariat, Sector-9 D, Chandigarh". Incomplete applications or applications not received through proper channel or applications received after the specified date shall not be entertained and would be straightway rejected.

6. The officers who are selected would normally be appointed initially for a period of 01 year extendable upto 03 years. They may be posted anywhere in the jurisdiction of Excise and Taxation Department, Union Territory Chandigarh. If the performance and /or the conduct of the officer is not found to be satisfactory during his/ her tenure at Excise and Taxation Department, Union Territory Chandigarh, the officer will be repatriated to the parent Department/ Commissionerate/ Directorate even before completion of the deputation period.
