Applications are invited from eligible and willing officers under the Central Government or State Governments or Union territory or statutory or autonomous organizations or public sector undertakings or recognized Universities or recognized research institutions for appointment to the following vacant posts in National Commission for Scheduled Tribes (NCST), proposed to be filled up on deputation basis

2. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for consideration for appointment by promotion
3. The selected officers will be posted in the NCST Headquarter at New Delhi or any of the regional offices located at Bhopal, Bhubaneswar, Jaipur, Raipur, Ranchi and Shillong, as decided by NCST.
4. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization / department of the Central Government shall ordinarily not exceed four years. The selected officers will be on deputation for a period of four (4) years initially which can be curtailed or extended further, depending upon the requirement and with the consent of the officer and approval of the lending department.
