Subject: - Filling up 02 posts of Superintending Engineer (Electric) in the pay level 13 as per 7th CPC pay matrix.

New Delhi Municipal Council proposes to fill up 02 posts of Superintending Engineer (Electric) on deputation basis. The pay scale, educations qualifications, eligibility criteria etc. of the posts as per extant Recruitment Rules is as follows:-

1. Pay Scale

Pay level 13 as per 7th CPC pay matrix.

2. Eligibility

Officers in the organizations under Central Government /State Govts. UT's.

- (a) (i) Holding analogous posts on regular basis; OR
- (ii) With 06 years' service in the grade rendered after appointment thereto on a regular service basis in the pay level 12 or equivalent in the parent cadre/department; OR
- (iii) With 12 years' service in the grade rendered after appointment thereto on regular basis in the pay level 11 or equivalent in the parent cadre/department; and

(b) Possessing the following educational qualifications and experience:
Essential:-

- (i) Degree in Electrical Engineering from a recognized university/institute or equivalent.
- (ii) 12 years experience in a large electricity supply undertaking having 11KV, 33 KV and 66KV transmission, overhead as well as underground distribution system along with experience in Electrification, distribution and Air conditioning of multi-storeyed buildings. The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation, similarly deputationist shall not be eligible for consideration for appointment by promotion.

(Note:- Period of Deputation contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or some other

organization/ Department of Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of the receipt of the applications).

3. **Tenure:-** For a period of 05 years as per DOPT OM dated 18.05.2018.
4. Applications along with proforma duly filled in of the eligible and suitable official/ officer fulfilling the above criteria and who can be spared immediately in the event of selection may be sent to the **Room No. 5001, Office of Director (Personnel – II), Palika Kendra, Sansad Marg, New Delhi – 110001**. The envelope containing application should be superscripted **"APPLICATION FOR THE POST OF SUPERINTENDING ENGINEER (ELECTRIC)"**

6. Applications of only such officers/candidates will be considered which are routed through proper channel and complete in all respect and are accompanied with (i) Bio data in the prescribed proforma (ii) ACRs/APARs for the last 5 years; and (iii) Latest vigilance /Cadre clearance. While forwarding the applications, it may be verified and certified that the particulars furnished by the officer are correct.
7. Applications received after the closing date is liable to be rejected.
