- b) The Attested copies of ACRs/APARs of the last five years.
- c) The Cadre Clearance Certificate, Integrity Certificate, Vigilance Clearance Certificate, and statement of Major/Minor penalties, if any, imposed on the candidate during last ten years, in original, or no penalty certificate, as the case may be, duly signed by the Competent Authority.
- d) The Certificate regarding as to no pendency of Court Case against the officer/official concerned.
