In supersession of the vacancy circular issued by this Ministry vide circular No. I-12014/01/2021-NCB-II dated 11.06.2021, it is proposed to fill up 01 (one) vacant post of Director General (DG) in Narcotics Control Bureau (NCB) under the Ministry of Home Affairs on deputation basis. The post was earlier in the pay matrix level-15 and has now been upgraded to the pay level 16/17 w.e.f. 02 June, 2021 with the approval of the competent authority. The terms and conditions of deputation will be governed by the Department of Personnel & Training's OM. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 & OM No. 2/6/2016-Estt.(Pay-II) dated 17.02.2016 as amended from time to time.
