**VACANCY CIRCULAR**

**Subject: - Appointment of Chairperson, Vice-Chairperson and 3 Members (Statutory Posts) of Co-operative Election Authority(CEA) -reg.**

The Multi State Cooperative Societies (Amendment) Act, 2023 has been notified vide Gazette Notification dated 03.08.2023 and MSCS Amendment Rules, 2023 have been notified vide Gazette Notification dated 04.08.2023. As per section 45(1) of the MSCS (Amendment) Act, 2023, the Central Government shall, by notification, establish an Authority to be known as Cooperative Election Authority (CEA) which shall consist of a Chairperson, a Vice Chairperson and Members not exceeding three to be appointed by the Central Government. The role, responsibilities and powers of CEA are as per Section 45 of the Multi State Cooperative Societies (Amendment) Act, 2023 and related Rules.

2. Therefore, it is proposed to appoint one Chairperson, one Vice-Chairperson and 3 (three) Members of the Co-operative Election Authority as per Annexed Terms /Conditions and Criteria.


3. Serving Officers in Central/ State Government working at the level of Additional Secretary and Joint Secretary or equivalent and above and Government Officers retired from equivalent ranks are eligible for appointment as Chairperson and Vice Chairperson, respectively. For Members of the CEA, serving/ retired government officials or any person who fulfil such qualification and experience as prescribed are eligible for the post. The eligibility conditions for appointment as Chairperson, Vice-Chairperson and Members of CEA are detailed in Annexure-I, II and III respectively.

4. Eligible and willing serving and retired officers of equivalent and above ranks may apply in the prescribed proforma in Annexure-IV for appointment as Chairperson, Vice- Chairperson and Member of CEA. The other eligible non official persons for appointment as Member of CEA may apply in proforma at Annexure-V.

5. Complete advertisement, application proforma with certificate formats, as applicable can also be downloaded from Ministry of Cooperation website- [www.cooperation.gov.in](http://www.cooperation.gov.in) (Link- What's New – Vacancies) and CRCS Website: [www.crcs.gov.in](http://www.crcs.gov.in).
