NOTICE INVITING APPLICATIONS FOR **ENGAGING VISITING PROFESSORs**

Applications are invited from eligible Civil Service Officers of the State and Central Governments including retired officers and other eminent persons from academia, research etc, for engaging one each Visiting Professor in following subjects in Sardar Vallabhbhai Patel National Police Academy, Hyderabad for a period of one year for taking modules/courses:

(i) Law

Cyber Law & Cyber Security.

(ii) Details of required educational Qualifications and experiences etc are as under: Eligibility criteria Visiting Professor Civil Service Officers of the State and Central Governments including retired officers and other eminent persons from 'Law' academia, research etc. (i) Eminent persons from outside Government should possess Ph.D in Law from recognised University at the time of his/her appointment. Candidates who have completed all the formalities of their Ph.D programme in Law subject (submission of thesis) and are awaiting award of their Ph.D. The condition should have at least five publications to her/his credit in renowned journals of her/his subject/domain. (iii) Besides, Government officers of the Central Government and State Governments including retired officers with a Master's Degree in Law from recognised University and 03 years experience in above subject. The serving officers will have to ensure that necessary permission and leave covering the period is obtained from the cadre controlling authority for this purpose. Civil Service Officers of the State and Central Governments Visiting Professor including retired officers and other eminent persons from 'Cyber Law & academia, research etc. Cyber Security" (i) Eminent persons from outside Government should possess Ph.D in any domain of criminal law from recognized University at the time of his/her appointment. Candidates who have completed all the formalities of their Ph.D programme in said subject (submission of thesis) and are awaiting award of their Ph.D. The condition should have at least five publications to her/his credit in renowned iournals of her/his subject/domain. (ii) Besides, Government officers of the Central Government and State Governments including retired officers with a Master's Degree in any

> domain of law or related fields from recognized University and 03 years experience relevant subject. The serving officers will have to

	ensure that necessary permission and leave covering the period is obtained from the cadre controlling authority for this purpose.
	Desirable Qualifications:
	 Candidates with PhD specialization (awarded or pursuing) related to Cyber law, cyber security and cybercrime. Industry standard certifications related to hacking, cybercrime investigation and cyber security. If the candidate is an academician, then candidates with teaching experience in the field of cyber law and cyber security. If the candidates is a practicing lawyer or a retired officer, then the Candidate with practical experience of handling cases as prosecutor/defense advocate in cyber offences or candidate with practical experience of handling Cyber crime investigation cases.
Remuneration.	(a)Retired government officers: (i)Last pay drawn minus basic pension. The amount so fixed shall remain unchanged during the term of appointment. (ii) No increment and dearness allowance shall be allowed during the term of the contract. (iii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
	(b) Eminent persons from outside Government: Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand only) per month.
Age	Minimum age of the candidate should be 28 years and the maximum age should not exceed 65 years at time of appointment.
Job profile	To impart training/modules in relevant subjects to the trainees attending various courses in the Academy. Such other duties entrusted to him / her from time to time in connection with training programmes etc.
Terms & conditions	(i)The Academy will provide furnished apartment subject to availability on the payment of a license fee as decided from time to time.
	(ii) Leave will be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed. In addition the Visiting Professors can leave headquarters for a total period not exceeding twenty days (20 days), inclusive of weekends and holidays during one year, which will be reduced proportionately depending on the months of engagement. Any leave however will require prior approval of the competent authority. Any period of absence above this will be treated as leave without pay. In the event of the engagement period being less than a year, the admissibility of the leave will be on a pro rata basis.
	(iii)Travelling Allowance/Daily Allowance and use of staff car/Academy taxi will be admissible only in case travel is undertaken at the behest of the Academy with the approval of the competent authority. For this purpose, the entitlements of an officer in the post of Assistant Director

of the Academy or as the case may be would be applicable.

- (iv) Medical facilities to the engaged Visiting Professor and his wife including minor children will be provided in the NPA Hospital only. No referral facility will be extended to him and his applicable family members.
- (v) Visiting Professors would be entitled to all the recreational and sports facilities of the Academy on the same terms and conditions as the rest of the Academy faculty.
- (vi) For any such conduct not conducive to the operating procedures of the Academy, the engagement of the concerned Visiting Professor will be terminated forthwith. The concerned Parent Organization/Unit shall also be intimated in case of Visiting Professor who are serving government employees regarding such act of misconduct or indiscipline for taking necessary action.
- (vii) The engagement will not bestow on him/her any right for claiming regular appointment in the Academy.
- (viii)The Academy reserves the right to cancel the entire selection, without assigning any reasons and without incurring any liability thereof.

The employer (SVP NPA) can modify, add, delete and amend/change above terms and conditions.

Duly filled-in applications, along with all supporting documents i.e educational qualification and experience certificates etc should reach the Assistant Director(Estt-I), SVP National Police Academy, Hyderabad 500052, on or before 25.08.2022 The retired officer will also submit a copy of Pension Payment Order issued by the government alongwith above documents.
