I. COMPANY PROFILE

An Agreement for implementation of the 1200 MW Punatsangchhu-I Hydroelectric Project was signed between the Government of India (GoI) and the Royal Government of Bhutan (RGoB).

Punatsangchhu-I Hydroelectric Project Authority (PHPA-I), an autonomous body was set-up for implementation of this Project. The Authority comprises a Chairman and four Members nominated by the Royal Government of Bhutan and three Members nominated by the Government of India.

The Project is headed by a Managing Director who is assisted by a Joint Managing Director, a Director (Finance) and a Director (Technical). Managing Director is the Member Secretary to the Authority and Joint Managing Director, Director (Finance), Director (Technical) are Permanent Invitees at the Authority Meetings.

II. ELIGIBILITY

The post of Director (Technical), PHPA-I carries enormous responsibilities. The post has, therefore, to be filled by a senior and an eminent candidate fulfilling the following eligibility criteria:

1. AGE: As on the last date of receipt of application:

Not more than 57 years.
3 years residual service w.r.t. the date of superannuation [Age of superannuation - 60 years]

2. EMPLOYMENT STATUS:
