### I. COMPANY PROFILE

Grid Controller of India Limited (GRID-INDIA) formerly known as Power System Operation Corporation Limited (POSOCO), is a wholly owned Government of India Company w.e.f. 3rd January, 2017. It is a Schedule 'A'/ Miniratna CPSE under the administrative control of Ministry of Power of the Government of India inter alia with the following mission: "Ensure Integrated Operation of the Indian Power System to facilitate transfer of electric power within and across the regions and trans-national exchange of power with Reliability, Economy and Sustainability"; "Facilitate competitive and efficient wholesale electricity markets and administer settlement systems".

GRID-INDIA has been entrusted with the responsibility of operating the National Load Despatch Centre (NLDC) and the five Regional Load Despatch Centre (RLDCs) w.e.f. 1st October, 2010.

GRID-INDIA has since been discharging the statutory function of power system operation as per the Regulations/ Standards laid down by Central Electricity Regulatory Commission (CERC) under the Electricity Act 2003.

Its Registered Office is at B-9, Qutab Institutional Area, Katwaria Sarai, New Delhi - 110016.

The company employed 631 regular employees (Executives: 588 & Non-Executives: 43) as on 31.03.2025.

The authorized and paid up capital of the Company are Rs. 200 crores and Rs. 40.85 crores respectively as on 31.03.2025.

The shareholding of the Government of India in the company is 100% as on 31.03.2025.

## II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Market Operation) is a member of the Board of Directors and reports to the Chairman and Managing Director. He/She is responsible for the commercial operations, electricity market operations, open access in inter-state transmission, Power Exchange operations, Accounting and settlement of electricity transmitted through the grid, deviation settlement, pool account operations, integration of renewable energy, REC mechanism, and legal and regulatory affairs.

#### III. ELIGIBILITY

#### 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and not in a contractual/ad-hoc capacity – in one of the followings:-

- (a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- (b) Central Government Group 'A' Officers including the Armed Forces of the Union and All India Services and officers from Public Sector Banks/ Financial Institutions/ Autonomous Bodies, etc;
- (c) State Public Sector Enterprise (SPSE) where the annual turnover is \*Rs.2,000 crore or more;
- (d) Private Sector in company where the annual turnover is \*Rs.2,000 crore or more. Preference would be given to candidates from listed Companies.
- (\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

### 3. QUALIFICATION:

The applicant should be an Engineering Graduate from a recognized University/ Institution with good academic record. Applicants holding MBA/ Post Graduate Diploma in Management or post graduate in Economics will have added advantage.

### 4. EXPERIENCE:

The applicant should have at least 5 years of cumulative experience, during the last 10 years, in Power Market Operations or Power system operations in an organization of repute.

## VI. UNDERTAKING BY THE APPLICANT

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

- 1. For candidates from Central Government including the Armed Forces of the Union and All India Services and officers from Public Sector Banks/Financial Institutions/ Autonomous Bodies etc:
- (a) The appointment is on immediate absorption basis.
- (b) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

### 3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
