I. AUTHORITY PROFILE

Punatsangchhu-II Hydroelectric Project (1020 MW) is being implemented in Bhutan under Inter-Governmental Mode by the Govt. of India (GOI) and Royal Govt. of Bhutan (RGoB).

Pursuant to the Inter Governmental Agreement signed between the India and Bhutan in 2010, the Punatsangchhu-II Hydroelectric Project Authority (PHPA-II) was set up for the construction, operation and maintenance of the 1020 MW Punatsangchhu-II Hydroelectric Project and for the evacuation of the surplus power from the Project. The Authority is constituted as an autonomous body with a Chairperson and Seven Members partly nominated by Royal Government of Bhutan and partly by Government of India. Managing Director, PHPA-II functions as the Secretary of the Authority.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Managing Director of the project will be the overall in-charge of the Project under the supervision and guidance of the Authority. He will be vested with sufficient powers to enable him to function in an effective manner and implement and operate the Project as per schedule. There will be a team of officials / experts under the Managing Director to assist him.

III. ELIGIBILITY

The post of Managing Director, PHPA-II carries enormous responsibilities. The Post has therefore to be filled by a person with ...
