(ii) with five years service in the grade rendered after appointment thereto on regular basis in post in the Pay Band-3 pay scale of Rs.15600-39100 Plus Grade Pay of Rs. 5400 or equivalent in the parent Cadre or Department; and

(b) possessing the following educational qualification and experience:

(i) Bachelor's degree from a recognized university or Institute with certificate of competency as Skipper (Fishing Vessel) or Mate (Foreign Going) or Master (Near Coast Vessel) issued by the Merchantile Marine Department and possessing five years experience on board a Fishing Vessel or Bachelor's degree in Fishery Science (Nautical Science) of a recognized university or institute with five years experience in the field of fisheries on board a fishing vessel or fisheries development activities; and

(ii) two years' experience in imparting training on Seamanship or Navigation.

Note 1: The departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.

Similarly, deputationists shall not be eligible for consideration for appointment by promotion. Period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three years.

Note 2 The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

Note: 3: For the purpose of appointment on deputation, the service rendered on a regular basis by an officer prior to 1 January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post for which that grade pay or pay scale is the normal replacement grade without any upgradation






