

I am to say that one post of **"Instructor(Workshop)"**, (Group 'B' Non-Gazetted, Non-Ministerial) in Level 6 in the Pay Matrix (ie. in the pre-revised pay band- 2 Rs. 9,300-34,800 Plus Grade pay of Rs.4,200/-) in Central Institute of Fisheries Nautical and Engineering Training Unit at Visakhapatnam is proposed to be filled on **deputation** (including short term contract) from amongst the Officers of the Central Government or State Governments or Union Territories or Universities or Recognized Research Institutions or Public Sector Organizations or Semi Government or Autonomous or Statutory Organizations;

- (a) (i) holding analogous post on regular basis in the parent cadre or Department; or
(ii) with six years' service in the grade rendered after appointment thereto on a regular basis in posts in Pay Band-I in the scale of Rs. 5200-20200 with Grade Pay of Rs.2800 or equivalent in the parent cadre or department; and

- (b) possessing the following educational qualification and experience:

Essential:

- (iii) Degree in Mechanical Engineering or Marine Engineering from a recognized University.
- (iv) One years experience of supervising welding or machining of fabrication, overhauling or fitting work of various machineries like pumps, compressors, boilers, etc. in a recognized Mechanical or Marine workshop or Institution.

Desirable: One year experience in overhauling of diesel engines.

The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(Period of deputation(including short term contract) including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation(including short term contract) shall not be exceeding 56 years as on the closing date of the receipt of applications)

Note: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the posts for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

Job description:

Supervision of Marine Engineering workshop and its upkeep. Imparting practical training in various engines, machines and equipments in the workshop to the institutional/post institutional trainees. Maintenance of workshop equipments. Repairs and maintenance of equipments on board the fishing vessel. Assist the CI(ME)/MME/Senior Instructor (Marine Engineering) in imparting training/theory classes if required. Undertake fishing cruise as shore officer participant for imparting practical training, associate with the training activities. Any other duties assigned by the superiors as per the requirements of the Institute

The place of posting will be at CIFNET Unit, Visakhapatnam, but likely to be posted in any of the 3 centers of CIFNET as per office requirement.

2. The pay of the official selected will be governed by the provisions laid down in the Department of Personnel and Training's O.M.No.6/8/2009-Estt(pay II) dated 17th June 2010.as amended from time to time.

3. Applications from eligible officers in the enclosed proforma (in duplicate) may be forwarded through proper channel to the Director, Central Institute of Fisheries Nautical and Engineering Training, Foreshore Road, Cochin -682 016 within a period of 60 days from the date of publication of this advertisement in the Employment News alongwith copies of upto date ACRs/APARs for the last five years, duly attested by an officer of the level of Under Secretary or above, vigilance clearance and integrity certificate.
