Subject: Filling up the post of Assistant Environmental Engineer (Group-A, Gazetted) and Junior Environmental Engineer (Group-B) in Punjab Pollution Control Board on deputation basis.

It is informed that there is a proposal to fill up the posts of following categories in the Punjab Pollution Control Board on deputation basis as per the provisions of the Punjab Pollution Control Board Employees Service Regulations, 2002:

- (i) Assistant Environmental Engineer (Group-A, Gazetted) (Pay Scale as 6th Pay Commission of Punjab with initial Pay of Rs. 47,600/-)
- (ii) Junior Environmental Engineer (Group-B) (Pay Scale as 6th Pay Commission of Punjab with initial Pay of Rs. 35,400/-)
- The eligibility criterion is given at Annexure-I.
- Applications of only such officers will be considered which are routed through proper channel and are accompanied with
 - (i) bio-data in the prescribed proforma at Annexure-II;
 - (ii) Documents to be attached as per Annexure-III;
 - (iii) Checklist to be verified by Controlling Authority at Annexure-IV;
 - (iii) Clear photocopies of the up-to-date APAR of the officer;
 - (iv) Cadre clearance;
 - (v) Clearance from vigilance and disciplinary angle; and
 - (vi) Statement giving details of major or minor penalties, if any, imposed on the officer
- 3. It is requested that the post may kindly be circulated amongst the eligible officers under your control and All Ministries/ Departments/ Boards/ Corporations and the State Governments/ UTs are requested to forward the

Applications of those against whom vigilance case is pending or disciplinary proceeding is contemplated need not to be forwarded.

- 4. Recruitment method: By way of Deputation
- Period of Deputation: The deputation period will be for a fixed period of two years only. No extension in deputation period will be given in any circumstances after the completion of two years.
- 6. Age Limit: Age of the official/ officer to be taken on the deputation shall not exceed 30 years.

7. Terms and Conditions

- (i) The officer shall be young, dynamic and well versed in environmental laws and is ready to work in the field.
- (ii) The officer may not have been recruited before the year 2020.
- (iii) Interview of the officer will be conducted by the Board by constituting of committee of officers before taking the official / officer on deputation.
- (iv) Financial liability of the Board in respect of the officer / official taken on deputation shall be strictly limited to the period of deputation in the Board.
- (v) The officer taken on deputation shall not be absorbed in the service of the Board in any manner.
- (vi) The appointing authority may impose any other condition which may deem appropriate in the facts and circumstances of the case.
- (vii) In addition to pay, the selected candidate will be entitled to dearness allowances admissible to Government Servants at the State/ Central Government rates.
- (viii) Special Compensatory Allowances and HRA as admissible under rules.
- (ix) Leave Travel Concession as admissible under rules.
