PUBLIC NOTICE

Sub:- Appointment on the post of Chairperson, Madhya Pradesh Electricity Regulatory Commission (MPERC) - Inviting applications.

Madhya Pradesh Electricity Regulatory Commission (MPERC) has been constituted with a Chairperson and two Members.

2/ The present Chairperson of MPERC is completing his tenure on 02.01.2025. Thus the vacancy will arise from 03.01.2025. Therefore, it is decided to invite applications from interested eligible persons for selection to the post of Chairperson of MPERC.

3/ In term of sub section (1) of section 84 of the Electricity Act, 2003, the Chairperson of MPERC shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. As per Sub-section 1 of Section 89 of the Electricity Act, 2003, the person finally selected for appointment on the post of Chairperson, MPERC, shall hold office for a term of five years from the date he/she assumes the charge or till he/she attains the age of 65 years, whichever is earlier.

4/ The person finally selected for appointment on the post of Chairperson of MPERC shall get Rs 2,25,000/- (fixed) per mensem. Other allowance and terms and conditions of service of Chairperson shall be as per Section 89 of the Electricity Act, 2003 read with Madhya Pradesh Electricity Regulatory Commission (Salary, Allowance and other Service Conditions of the Chairperson and Members) Rules, 2000 (as amended from time to time).

5/ It is further prescribed that the applicant shall have to give a declaration / undertaking as per provision of Sub-section 5 of Section 85 of the Electricity Act, 2003, stating that he/she does not have any financial or other interests, which may affect prejudicially his/her functions as Chairperson of MPERC. A declaration in format given

at Annexure-I should be furnished by the candidate along with the application. The person shall also have to give undertaking that on appointment on the post of Chairperson, MPERC, he/ she will resign from the post he/she holds.

6/ The eligible applicants who are in service may submit the application along with relevant information and undertakings to their employer who will forward the application along with No Objection Certificate and the past 5 years ACR grading at the following address, latest by 17.09.2024. However, the applicant may forward an advance copy to this department.
