**COMPANY PROFILE:**

NTPC Ltd. is India's largest energy conglomerate headquartered in New Delhi with total installed capacity (including JVs) of 76294 MW.

NTPC is incorporated under the Companies Act 1956 and is a "Maharatna" PSE under the administrative control of Ministry of Power, Government of India.

The company has 30 coal based, 8 gas based, 1 hydro, 8 green field solar, 1 wind station and 2 operating coal mines. Currently 15 GW projects are under construction and 5 more coal mines are in various stages of operation.

The shareholding of the Government of India (GOI) in NTPC is 51.1%

**IMPORTANCE OF LAND:**

Land is a critical resource for setting up of projects including thermal, hydro, renewable, nuclear energy and coal mining projects. NTPC is engaged in land acquisition for various projects which involves obtaining various clearances and liaison with the appropriate central/state government authorities.

Land acquisition under the extant Land Acquisition Act, Coal Bearing Act (CB), including statutory clearances which involves various processes and formalities, is critical for the business of NTPC. Timely completion of these formalities is integral for the smooth functioning and timely completion of the project.

**BROAD JOB DESCRIPTION & RESPONSIBILITIES OF CHIEF CORDINATOR (LAND)**

1. The person so appointed should be well versed with land related matters including related clearances from various Central/State/Development authorities.

2. Assisting various projects, stations, coal mining sites, hydro projects and other group companies including JVs in obtaining various clearances and ensuring compliance thereof.
3. Liaison with various Ministries/Central/State Govt Authorities/Development authorities including Industry, forest, revenue, environment etc.
4. Any other related activity as deemed fit and necessary for business operations of the company.

**ELIGIBILITY:**

1. Should be a graduate from recognised university. Candidates with Qualification of MBA will be given preference.
2. A serving Govt officer/officer of State PSEs in the CPSE pay scale of 100000-260000/- and above or equivalent pay scale
