#### OFFICE MEMORANDRUM

Subject: Filling up of post of Secretary in the Competition Commission of India on deputation/promotion basis.


The Competition Commission of India invites applications from eligible Officers of the Central Government or State Governments for appointment to the post of Secretary by the Composite Method of deputation on foreign service terms/ promotion. The details of the post, along with eligibility criteria, educational qualification/experience etc. required for the post are given in Annexure-I.

- 2. In case of selection on deputation basis, appointment to the post will be made on deputation on foreign service terms basis initially for a period not exceeding 3 years, which can be extended upto 7 years and would be governed by the terms and conditions prescribed by the Department of Personnel and Training, Government of India, vide O.M. No.6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time, as well as by GoI Notification No. GSR 670 (E) dated 14.09.2009, as amended from time to time regarding conditions of service of Secretary, Officers and other employees of CCI.
- 3. The maximum age limit for appointment to the post on deputation basis shall be 'not exceeding fifty eight years' on the closing date of receipt of application in the Competition Commission of India (CCI). However, in case of selection of a departmental candidate, appointment to the post will be made on promotion basis.
- 4. The prescribed age limit, educational qualifications and other eligibility conditions should be fulfilled by the applicants as on the closing date and time prescribed for receipt of applications in CCI.
- 5. Apart from basic pay, the post carries DA, HRA and Transport Allowance etc. as applicable to the Central Government employees from time to time. Medical reimbursement is admissible as per the CCI service rules. This is in lieu of CGHS benefits which are not admissible to the employees of CCI. The CCI is an eligible office for allotment/retention of Government Accommodation from General Pool.
- 6. The Power and functions of the Secretary are governed in terms of 'The Competition Commission of India (General) Regulations, 2009 (No. 2 of 2009)' and the brief details of the same are given at Annexure -II.

- 7. Applications, complete in all respects, of eligible and willing candidates whose services can be spared for appointment to the post of Secretary, CCI may be forwarded, through proper channel, in the prescribed Pro-forma as per <u>Annexure-III</u>, together with all necessary documents i.e. cadre clearance, vigilance clearance, copies of APARs of last five years and Certificate from the Employer, so as to reach the <u>Joint Director (HR)</u>, <u>Competition Commission of India</u>, 9<sup>th</sup> <u>Floor</u>, <u>Office Block-1</u>, <u>Kidwai Nagar (East)</u>, <u>New Delhi-110023</u> latest by 7<sup>th</sup> <u>August</u>, 2023 (5:00 P.M.).
- 8. It is clarified that any form of conditional forwarding from the employer or applications received without the prescribed documents and Certificate from the Employer shall be summarily rejected. Applications which are received after the prescribed date and time i.e. 7<sup>th</sup> August, 2023 (5:00 P.M.) will not be considered.
- 9. The Commission takes no responsibility for any delay in receipt of application or loss thereof in postal transit. Therefore, the applicants must ensure that their application, complete in all respect, should reach CCI through proper channel by the last date and time prescribed for receipt of applications.
- 10. The applicants who have submitted applications to the post in response to the earlier advertisement of even number dated 01.08.2022 shall submit fresh applications, complete in all respects, through proper channel, as per this notification, if interested. It is made clear that the applications submitted earlier in response to the advertisement dated 01.08.2022 shall not be considered.
- 11. Canvassing in any form will disqualify the candidate.
- 12. No TA/DA shall be payable in case a candidate is called for an interaction with the Selection Committee constituted for the said post.
- 13. The Commission reserves the right not to fill up the above vacancy.

# Powers and functions of the Secretary, CCI.

The power and functions of the Secretary, CCI are governed by the provisions of 'The Competition Act, 2002' and 'The Competition Commission of India (General) Regulations, 2009 (No.2 of 2009)', as amended from time to time.

- (1) The Secretary shall be the nodal officer on behalf of the Commission for making or receiving all statutory communications, entering into any formal relationships, including signing of any memorandums or arrangement with competition authority or any agency of any foreign country, with the prior approval of the Commission and the Central Government, as per section 18 of the Act.
- (2) The Secretary is the custodian of records of the Commission and shall exercise such other functions as may be assigned by the Chairperson.
- (3) Subject to the provisions of section 51 of the Act, the Secretary shall assist the Committee of Members constitutes under Sub-section (3) of Section 51 of the Act, for preparation and approval of the Annual budget of the Commission and administration of the Competition Fund.
