ORDER

Sub: Conducting of common Assistant Accounts Officer (AAO) Examination in Govt. of N.C.T. of Delhi by DSSSB - reg.

Whereas, DSSSB has been entrusted to recommend suitable candidates for appointment in various departments of Government of NCT of Delhi and local bodies/PSUs under the direct recruitment quota to Group 'B' and 'C' categories of posts as per resolution No.F.3(24)/DSSSB/2008-S.III/1764 dated 12th May, 2008.

Whereas, in exercise of the powers under the GNCTD Accounts Services Rules, 2012, the Department of Finance has issued the Regulations for this examination. Moreover, as per the clause 2(b) of the Regulations, this limited departmental qualifying examination is to be conducted by PAO or any other department / agency on behalf of GNCTD.

Further, DSSSB has been mandated to perform any other related task entrusted to it subject to the guidelines issued by GNCTD for making recommendations against Group-B and C posts as per clause 3(A)(vi) (i.e. Duties and Responsibilities) of 2008 Resolution of DSSSB.

Whereas, Pr. Accounts Office has requested DSSSB to conduct the common AAO examination for the employees of Govt. of N.C.T. of Delhi, Delhi High Court, O/o District and Session Judge and Delhi Jal Board, keeping in view the authorization given by Hon'ble Lt. Governor, Delhi and a pending Court Case before Hon'ble High Court of Delhi.

Hence, the approval of Hon'ble Lt. Governor, Delhi is hereby conveyed that henceforth DSSSB will conduct the common AAO examination.
