**ORDER NO. 2**

In pursuance of directions of Hon'ble CAT dated 28.05.2015 in the matter of MA No.2494/2014 & MA No.2495/2014 in OA No.1548/2003 in the matter of Sunil Kumar & Ors Vs. Govt. of NCT of Delhi and Ors. regarding grant of the financial upgradation to the 07 Gr.IV(DASS)/LDC officials after counting of their past service rendered in the DEDA(an autonomous body) and accordingly the recommendations of the Screening Committee constituted for review cases of 1<sup>st</sup> financial upgradation earlier granted under the ACP Scheme, the ACP granted to these officials vide Letter No.F.4(1)/2013/ACP/Services/Gr.IV(DASS)/359-370(Order No.12) dated 22.03.2013 is hereby reviewed w.e.f. the dates mentioned against each.
