However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his

The Head of Department concerned is requested to ensure before issuing final order that 30 years regular service of the official does not include the period of service rendered in State Government/Statutory Body / Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.09)

The concerned Head of Department is requested to issue formal order for grant of the 3rd financial upgradation in respect of the above mentioned official working in the Department. However, before the issuance of the formal orders the Head of Department may again confirm that the official has completed 30 years regular service with two promotions since the date of their initial appointment in the service and is clear from Vigilance angle.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
