On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Modified Assured Career Progression Scheme to Grade-II (Steno) officials in accordance with the instructions contained in OM No.35034/3/2008-Estt. (D) Dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to nominate the following **26 (Twenty Six)** Grade-II (Steno) officials on the Completion of 20 years of regular services with one promotion for grant of 2nd Financial Up-gradation under the Modified Assured Career Progression Scheme from the corresponding Pay Band-II of Rs. 9300-34800/-; Grade Pay Rs. 4200/- to the immediate next higher Grade Pay of Rs. 4600/- in the hierarchy of the recommended revised pay bands w.e.f the dates mentioned against their name :-

However, the grant of higher pay scale is subject to the under taking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.

The concerned Head of Department is requested to ensure before issuing final order that 20 years of regular service of the officials does not include the period of service rendered in Autonomous body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial up-gradation under MACP Scheme. (Point No.10 of DOPT OM dated 19.05.2009)

The concerned Heads of Departments are requested to issue formal order for the Grant of 2nd financial up-gradation in respect of the above mentioned officials working in their Department. However, before the issuance of the formal orders the Head of Departments may again confirm that these officials have completed 20 years of regular service with one promotion since the date of their initial appointment in the service and are **clear from the vigilance angle**.

The officials who are on deputation will get financial up-gradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to the Delhi Government.
