In pursuance of directions of Hon'ble High Court dated 27.05.2015 in WP(C)No.18629/2005 in the matter of M.L.Bhatt Vs. Govt. of NCT of Delhi and Ors. regarding grant of 1st financial up gradation under the ACP Scheme in respect of Sh. M.L. Bhatt, (DOB.30.06.54), UDC(Retired) after counting of past service rendered in the DSMDC (an autonomous body) and as per the recommendations of the Screening Committee constituted for grant of 1st financial up gradation under the Assured Career Progression Scheme in accordance with the instructions contained in O.M.No. 35034/1/97 Estt.(D) dated 09.08.99 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 1st financial up gradation under ACP Scheme to the following Gr.IV(DASS) official on completion of 12 years of regular service in the next higher pay scale of Rs.4000-6000 (pre revised) w.e.f. the date mentioned against the name :-

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage, the same will be recovered from his pay.

The official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.

The concerned Head of Department is requested to ensure before issuing final order that official is clear from vigilance angle.

In case of employee declared surplus and redeployed in Delhi Govt., HOD may ensure before issue of final order that concerned official has not been given any financial up gradation/ promotion and completed at least 12 years of regular service for 1st financial up gradation during his tenure including service prior to redeployment in Govt. of NCT of Delhi.

The concerned Head of Department/Head of Office is requested to issue formal order for grant of the financial up gradation in respect of the officials working in his departments. However, before the issuance of the final orders the Head of Department may again confirm that the official has not been given any promotion since the date of initial appointment in his service and completed at least 12 years of regular service on the date of granting financial up gradation without promotion.
