The official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.

The concerned Head of Department is requested to ensure before issuing final order that official is clear from vigilance angle.

In case of employee declared surplus and redeployed in Delhi Govt., HOD may ensure before issue of final order that concerned official has not been given any financial up gradation/ promotion and completed at least 12 years of regular service for 1st financial up gradation during his tenure including service prior to redeployment in Govt. of NCT of Delhi.
