On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Modified Assured Career Progression Scheme to Grade-II, DASS officials in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 19.05.09 & OM No.22/22/2009-CSI(CR) dated 12/13.04.2010 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Competent Authority is pleased to grant third financial upgradation to the following DR Grade-II DASS officials, now working as Grade-I DASS or Adhoc DANICS/DANICS, who have got Non-functional Grade (NFG) in PB 3 Grade Pay of Rs. 5400/- , in the immediate higher Grade Pay of Rs. 6600/- on completion of 30 years of continuous service or on completion of 10 years stagnation in a single Grade Pay, whichever is earlier, w.e.f. the dates mentioned against their names:-

2. The grant of MACP is further subject to the condition that:-

- (I) No further financial upgradation under MACP would be admissible to these officers.
- (II) The officer concerned may be allowed to exercise their options if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- (III) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
- (IV) The concerned Departments to ensure before releasing the financial benefits on account of third MACP:-
 - (i) That the official has been appointed as Direct Recruit (DR) DASS.
 - (ii) That particulars of the officers with regard to date of appointment as DR Grade-II DASS, date of promotion as Grade-I DASS, date of grant of Non Functional scale as Grade-I DASS, as mentioned above

- (iii) That the officer is clear from vigilance angle at all levels including MHA, wherever applicable.
