**ORDER No. 11**

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Grade-III (Steno) officials in accordance with the instructions contained in OM No.35034/1/97-Estt.(D) dated 9.8.99 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to nominate the following Grade-III (Steno) officials for grant of 1<sup>st</sup> Financial Up-gradation in the pay scale of Rs.5500-9000 w.e.f. the dates mentioned against their names:-

The officials concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the under taking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.

The concerned Head of Departments are requested to ensure before issuing final order that 12 years of regular service of the official does not include the period of past service rendered in Autonomous body/Statutory body/State government as the period of past service in these bodies is not to be counted for grant of financial upgradation under ACP Scheme. (Clarification No.43 of DoPT OM dated 18.07.2001.
