On the recommendation of the Screening Committee constituted for grant of financial up-gradation under the Modified Assured Career Progression Scheme to Gr-IV(DASS) official in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant the following **02** Gr-IV(DASS) officials, who were initially appointed as LDC/Data entry operator and later taken on Cadre strength of Govt. of NCT of Delhi as Gr.IV(DASS) vide notification of Services IV Branch issued on dated 16.04.07, on the completion of 20 years of regular service for grant of 2<sup>nd</sup> financial up-gradation from existing grade pay of Rs.2400/- to the immediate next higher grade pay of Rs.2800/- w.e.f. the date mentioned against their name:-

The official concerned may be allowed to exercise their options if any under FR 22 within one month of the issuance of the order granting the financial up gradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered from his pay.

The Head of Departments concerned are requested to ensure before issuing final order that 20 years of regular service of the officials does not include the period of service rendered in State Government/ statutory body/Autonomous Body/Public Sector organization as the period of past service in these bodies is not to be counted for grant of financial up gradation under MACP Scheme (Point No.10 of DoPT OM dated 19.05.09.)

The concerned Head of Departments are requested to issue formal order for grant of the 2<sup>nd</sup> financial up gradation in respect of above mentioned officials working in their Departments. However, before issuing formal orders again confirm that the officials have completed 20 years of regular Service with one promotion/ financial up gradation since the date of her initial appointment in the service and is clear from Vigilance Angle.

The official who is on deputation will get financial up gradation from the dates shown against their names only on notional basis. However, he/she will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of his/her repatriation to Delhi Government.
