ORDER NO. 15


In pursuance of directions of Hon'ble High Court dated 27.05.2015 in WP(C)No.18629/2005 & M.A. No.3148/2015 in the matter of M.L.Bhatt Vs. Govt. of NCT of Delhi and Ors. regarding grant of 2<sup>nd</sup> financial up gradation under the MACP Scheme in respect of Sh.M.L. Bhatt, (DOB.30.06.54), UDC(Retired) after counting of past service rendered in the DSMDC(an autonomous body) and as per the recommendations of the Screening Committee constituted for grant of 2<sup>nd</sup> financial up gradation under the Modified Assured Career Progression Scheme in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 2nd financial up gradation under MACP Scheme w.e.f.01.09.08 date of implementation of MACP Scheme or on completion of 20 years of regular service with promotion in the pay scale of Rs.5200-20200/- from the existing Grade Pay of Rs.2400/- to the immediate next higher Grade pay of Rs.2800/- in the hierarchy of the revised pay bands w.e.f. the date mentioned against the name :-

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage, the same will be recovered from his pay.

The official concerned may be allowed to exercise his option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.

In case of employee declared surplus and redeployed in Delhi Govt., HOD may ensure before issue of final order that concerned official has not been given more than one financial up gradation/promotion and completed at least 20 years of regular service for 2<sup>nd</sup> financial up gradation during his tenure including service prior to redeployment in Govt. of NCT of Delhi.
