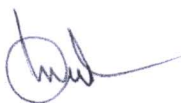

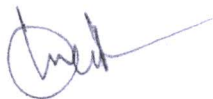

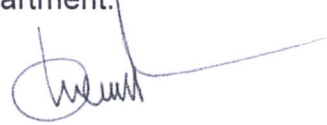
2. The grant of MACP is further subject to the condition that:-

- (I) No further financial upgradation under MACP would be admissible to these officers.
- (II) The officer concerned may be allowed to exercise their options if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.
- (III) The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
- (IV) The concerned Departments to ensure before releasing the financial benefits on account of third MACP:-

(i) That the official has been appointed as Direct Recruit (DR) DASS.



(ii) That particulars of the officers with regard to date of appointment as DR Grade-II DASS, date of promotion as Grade-I DASS, date of grant of Non Functional scale as Grade-I DASS, as mentioned above are correct. Discrepancy, if any be brought to notice of this Department and the orders in respect of such officer(s) may not be implemented till clarification from this Department.
