ORDER 22

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Grade-III (DASS)/UDC officials in accordance with the instructions contained in office memorandum no.35034/1/97-Estt.(D) dated 9.8.99 of Govt. of India, Ministry of Personnel, Public Grievances & Pension (Department of Personnel & Training), the Competent Authority is pleased to grant Second Financial Up-gradation under ACP Scheme on completion of 24 years of regular service in respect of the following 03 Gr-III (DASS)/UDC officials from the pay scale of Rs. 4000-6000/- (Pre-revised) to next pay scale of Rs. 5500-9000/- (Pre-revised) w.e.f. the date mentioned against their names. Services Department vide Order No. 57 dated 03.02.2015 revised the pay structure of Grade II (DASS) & Stenographer Gr. II in the PB-2 Rs. 9300-34800 from Grade Pay of Rs. 4200/- to Rs. 4600/- w.e.f. 01.01.2006.

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career Progression Scheme.


However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The Head of Department concerned is requested to ensure before issuing final order that 24 years regular service of the officials does not include the period of service rendered in State Government/Statutory Body/ Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial up-gradation under ACP Scheme.

The Head of Department /Head of Offices are requested to ensure before issuing final order that the above officials have fulfil the requirement as mentioned in point No.4 and 5.1 of Annexure-1 of ACP Scheme introduced by DoPT Govt. of India.

The concerned Head of Departments are requested to issue formal orders for grant of 2<sup>nd</sup> financial up-gradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Head of departments may again confirm that these officials have completed 24 years regular service with one promotion since the date of their initial appointment in the service and are clear from vigilance angle.

The officials who are on deputation will get financial up-gradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
