However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from his pay.

The Head of Department concerned is requested to ensure before issuing final order that 20 years regular service or 10 years continuous in the same Grade Pay of the officials does not include the period of service rendered in State Government/Statutory Body / Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.09).

The concerned Head of Department are requested to issue formal order for grant of the 2nd financial upgradation in respect of the above mentioned official working in the Department.
