ORDER NO. 25

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Gr.IV(DASS) officials in accordance with the instructions contained in O.M. No. 35034/1/97 Estt.(D) dated 09.08.1999 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Secretary (Services) is pleased to grant 2<sup>nd</sup> financial up gradation under ACP Scheme to following Gr.IV (DASS)/LDC official on completion of 24 years of regular service with one financial up gradation/promotion from the pay scale of Rs.4000-6000/-(pre-revised) in the next higher pay scale of Rs.5500-9000/-(pre-revised) w.e.f. the date mentioned against the name :-

The official concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Department is requested to ensure before issuing final order that 24 years of regular service of the officials does not include the period of past service rendered in Autonomous body/Statutory body/State Govt. as the period of past service in these bodies is not to be counted for grant of financial up-gradation under ACP Scheme. (Clarification No.43 of DOPT OM dated 18.7.2001)

The Head of Department/ Head of Office is requested to ensure before issuing the final order that the above officials have fulfill the requirement as mentioned in Point No 4 and 5.1 of Annexure -1 of ACP Scheme introduced by DoPT, Govt. of India.

The concerned Head of Department is requested to ensure before issuing final order that **official is clear from vigilance angle** and has completed 24 years of regular service in the Govt. of NCT of Delhi on the date of granting financial up-gradation with one financial upgradation/promotion.
