The officials concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Departments are requested to ensure before issuing final order that 24 years of regular service of the officials does not include the period of past service rendered in Autonomous body/Statutory body/State Govt. as the period of past service in these bodies is not to be counted for grant of financial up-gradation under ACP Scheme. (Clarification No.43 of DOPT OM dated 18.7.2001)

The Head of Departments/ Head of Offices are requested to ensure before issuing the final order that the above officials have fulfill the requirement as mentioned in Point No 4 and 5.1 of Annexure -1 of ACP Scheme introduced by DoPT, Govt. of India.

The concerned Head of Departments are requested to ensure before issuing final order that officials are clear from vigilance angle and were not been given in-situ promotion and fast-track promotion availed through limited departmental competitive examination. These officials have completed 24 years of regular service in the Govt. of NCT Delhi on the date of granting financial up-gradation with one financial upgradation/promotion.

The officials who are on deputation will get financial up gradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
