On the recommendation of the Screening Committee constituted for grant of 2nd financial up-gradation under the Modified Assured Career Progression Scheme to 13 Gr-IV (DASS) officials in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel & Training), the Pr. Secretary (Services) is pleased to grant the following Gr-IV(DASS) officials on the completion of 20 years of regular service with promotion in the PB-I pay scale of Rs. 5200-20200/- with present grade pay of Rs.1900/- to the immediate next higher grade pay of Rs.2000/- in the hierarchy of the revised pay bands w.e.f. the date mentioned against their names:-

The officials concerned may be allowed to exercise their options if any under FR 22 within one month the issuance of the order granting the financial up gradation under the modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment which may be detected at a later stage the same will be recovered from their pay.

The Head of Departments concerned are requested to ensure before issuing final order that 20 years of regular service of the officials does not include the period of service rendered in State Government/ statutory body/Autonomous Body/Public Sector organization as the period of past service in these bodies is not to be counted for grant of financial up gradation under MACP Scheme (Point No. 10 of DoPT OM dated 19.05.09).

The concerned Head of Departments are requested to issue formal order for grant of the 2nd financial up gradation in respect of above mentioned officials working in their Departments. However, before issuing formal order again confirm that these officials have completed 20 years of regular Service with promotion since the initial appointment in the service and are clear from Vigilance Angle.

The officials who are on deputation will get financial up gradation from the dates shown against their names only on notional basis. However, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
