ORDER NO. 28

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Gr.IV(DASS) officials in accordance with the instructions contained in O.M. No. 35034/1/97 Estt.(D) dated 9.8.99 of the Govt. Of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant 1st financial up gradation under ACP Scheme on completion of 12 years regular service in respect of following 04 Gr.IV (DASS)/LDC officials in the next higher pay scale of Rs.4000-6000 (pre revised) w.e.f. the date mentioned against their names:-

The official concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Assured Career progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Heads of Departments are requested to ensure before issuing final order that 12 years of regular service of the officials does not include the period of past service rendered in Autonomous body/Statutory body/State Govt. as the period of past service in these bodies is not to be counted for grant of financial up-gradation under ACP Scheme. (Clarification No.43 of DoPT OM dated 18.7.2001)

The Head of Departments/ Head of Offices are requested to ensure before issuing the final order that the above officials have fulfill the requirement as mentioned in Point No 4 and 5.1 of Annexure – 1 of ACP Scheme introduced by DoPT, Govt. of India.

The concerned Head of Departments are requested to ensure before issuing final order that officials are clear from vigilance angle and the Class IV employees have not been given in-situ promotion and fast-track promotion availed through limited departmental competitive examination.

The concerned Head of Departments/Head of Offices are, however, requested before issuing the formal orders for the grant of 1st financial up-gradation in respect of the above officials, to confirm again that these officials have completed 12 years of regular service in the Govt. of NCT of Delhi on the date of getting financial up-gradation without promotion.

The officials who are on deputation will get financial up gradation from the dates shown against their names **only on notional basis**, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
