ORDER NO 31

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Modified Assured Progression Scheme to Gr.III (DASS) /UDC officials in accordance with the instructions contained in O.M. No. 35034/3/2008-Estt. (D) dated 19.05.09 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training), the Pr. Secretary (Services) is pleased to grant the following **(05)** Gr.III (DASS)/UDC officials on completion of 20 years regular service with one promotion or spent 10 years of continuous service in the same Grade Pay for grant of 2ND financial up-gradation from the corresponding Pay Band-I of Rs.5200-20200; Grade Pay of Rs.2400/- to the immediate next higher Grade Pay of Rs.2800/- in the hierarchy of the recommended revised pay bands w.e.f. the dates mentioned against their names:-

The officials concerned may be allowed to exercise their option, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Modified Assured Career Progression Scheme.

However, the grant of higher Grade Pay is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The Head of Departments concerned are requested to ensure before issuing final order that 20 years of regular service of the officials does not include the period of service rendered in State Govt. /Statuary Body/Autonomous Body/Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial up-gradation under MACP scheme (Point No. 10 of DoPT O.M. dated 19.05.09).

The concerned Head of Departments are requested to issue formal orders for grant of the 2nd financial up-gradation in respect of the above mentioned officials working in their departments. However, before the issuance of the formal orders the Head of Departments may again confirm that these officials have completed 20 years of regular service with one promotion since the date of their initial appointment in the service and **are clear from Vigilance angle.**

The officials who are on deputation will get financial up-gradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government.
