**ORDER No. 32**

In view of direction of Hon'ble High Court, Delhi Dated 05/11/2014 in the matter of W.P (c) 1378/2014, CM No 2879/2014 titled "GNCT of Delhi and Ors. Vs Narender Singh" and decision of Hon'ble Central Administrative Tribunal (CAT) in the matter of MA/2494/2014, OA No/1548/2003 & MA/2495/2014 "Govt. Of Delhi Vs Sunil Kumar & Ors", for counting of past service for benefits of ACP/MACP scheme to the officials having rendered their services in DEDA/DSMDC and were declared surplus & further re-deployed in GNCT of Delhi and on the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Assured Career Progression Scheme to Gr. III (Stenographers) in accordance with the instructions contained in OM NO. 35034/3/2008-Estt.(D) dated 9-8-1999 of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Dep'tt. of Personnel & Training), the Secretary (Services) is pleased to grant 1<sup>st</sup> Financial Upgradation under ACP scheme on completion of 12 years of regular service with no promotions from the pay scale of Rs. 4000 – Rs. 6000 (pre revised) to the next pay scale of Rs. 5500-9000 (pre revised) (upgraded to Rs. 9300-34800 in PB-2 with GP Rs. 4600/- w.e.f. 01.01.2006) to the following Stenographer, Gr. III w.e.f. the date mentioned against her name :

The Official concerned may be allowed to exercise her options, if any, under FR 22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

In case of employees declared surplus and redeployed in Delhi Govt., HODs may ensure before issue of final orders that concerned officials have not been given any financial upgradation / promotion and completed 12 years of regular service for 1<sup>st</sup> Financial upgradation during their tenure including service prior to redeployment in GNCT of Delhi.

The concerned Head of Departments are requested to issue formal order for grant of the 1<sup>st</sup> financial upgradation in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Heads of Departments may again confirm that these officials have completed 12 years regular service with no promotions or 12 years of continuous service in the same grade pay and are clear from Vigilance angle.
