**ORDER NO. 33**

On the recommendations of the Screening Committee constituted for grant of financial up-gradation under the Modified Assured Career Progression Scheme to Grade-II (DASS) / H.C. officials, in accordance with the instructions contained in OM No. 35034/3/2008-Estt.(D) dated 19.05.2009 of the Govt. of India, Ministry of Personnel Public Grievances & Pensions (Deptt. of Personal & Training), the Pr. Secretary (Services) is pleased to grant the following 12 Grade-II (DASS) / H.C. officials, who were initially appointed as Assistant Project Officer in Urban Development Department and later taken on Cadre Strength of Govt. of NCT of Delhi vide notification of Services -IV Department dated 12.12.2008 & Order No.01 dated 01.01.2009 of Services-II Department, on completion of 20 years of regular service, for grant of 2<sup>nd</sup> financial up-gradation from the existing Grade Pay of Rs. 4600/- to the immediate next higher Grade Pay of Rs. 4800/- w.e.f. the date mentioned against their names.

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the financial up-gradation under the Modified Assured Career Progression Scheme.

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage, the same will be recovered from their pay.

The concerned Head of Departments are requested to ensure before issuing final order that 20 years regular service of the officials does not include the period of service rendered in State Government / Statutory Body / Autonomous Body / Public Sector Organization as the period of past service in these bodies is not to be counted for grant of financial upgradation under MACP Scheme. (Point NO.10 of DOPT OM dated 19.05.2009). The Concerned Head of Departments / Head of offices are also requested to ensure before issue of final orders that concerned officials have been availed only one financial upgradation / promotion and completed 20 years of regular service for 2<sup>nd</sup> financial upgradation.

The concerned Head of Departments are requested to issue formal orders for grant of 2<sup>nd</sup> financial upgradation under MACP Scheme in respect of the above mentioned officials working in their Departments. However, before the issuance of the formal orders the Head of departments may again confirm that these officials have completed 20 years regular service, with one promotion/financial upgradation since the date of their initial appointment in the service and are **clear from vigilance angle**.

The officials who are on deputation will get financial upgradation from the dates shown against their names **only on notional basis**, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to Delhi Government
